JUDGMENT

The petitioner who is a member of the 4th respondent Co-operative Society has filed this writ petition seeking a writ of mandamus compelling respondents 1 to 3 to conduct election to the 4th respondent Co-operative Society within a time limit to be fixed by this Court and for other consequential reliefs.

2. Today, when the case was taken up for final hearing, the learned Government Pleader on instructions submitted that pursuant to the judgment of this Court in W.P.(C). No.22698/2013, election to the Managing Committee of the 4th respondent Society has already been conducted on 19.03.2014 and the elected Committee has already been taken charge.
