JUDGMENT

This writ petition pertains to dismantling of the electricity connection from the premises occupied by the petitioner. The application for license put in by the petitioner to conduct the work shop admittedly stands rejected. The same has become final by the dismissal of WPC No.31352/2010 filed by the petitioner. The petitioner cannot therefore complain of the electricity connection being dismantled to the premises. This is because the petitioner cannot operate the work shop in the premises in the absence of a valid license.

The writ petition is dismissed. No costs.
