JUDGMENT

This writ Petition was filed by the petitioner, who was undergoing plus one course in St.George Higher Secondary School, Aruvithura. She has approached this court in this writ petition seeking a writ of mandamus commanding the 2nd respondent Principal to permit her to continue her studies for plus one course based on Ext.P1 community certificate.

2. By order dated 12.8.2009, this Court passed an interim order directing the 2nd respondent to permit the petitioner to continue her studies on the basis of Ext.P1 community certificate, pending disposal of this writ petition.
