J U D G M E N T

The petitioner has approached this Court challenging the revenue recovery proceedings.

2. The only relief sought before this Court is to permit the petitioner to discharge the entire liability in equal monthly instalments.

3. Considering the facts and circumstances, the petitioner is given liberty to discharge the entire liability in 12 monthly instalments stating from 05.07.2015 onwards. If the petitioner fails to pay any of the instalments as stipulated above, the Bank is at liberty to initiate revenue recovery proceedings against the petitioner.

4. The revenue recovery proceedings shall be deferred to in tune with the directions as above.
