J U D G M E N T

The petitioner who has been working as an Assistant Executive Engineer at Chengamanad, Aluva, since 1.9.2014, is aggrieved by Ext.P5 order of transfer, whereby, he has been transferred to Moolamattom. Aggrieved by the said order of transfer, the petitioner has preferred Ext.P8 representation before the 2nd respondent, and the limited prayer of the petitioner in the writ petition is for a direction to the 2nd respondent to consider and pass orders on Ext.P8 representation within a stipulated time frame, and to retain the petitioner at Aluva till such time as orders are passed by the 2nd respondent on the said representation.

2. I have heard the learned counsel for the petitioner as also the learned Standing counsel for the respondents.

On a consideration of the facts and circumstances of the case as also the submissions made across the bar, I dispose the writ petition

with a direction to the 2nd respondent to consider and pass orders on Ext.P8 representation preferred by the petitioner within a period of one month from the date of receipt of a copy of this judgment, after hearing the petitioner. I make it clear that till such time as orders are passed by the 2nd respondent, and communicated to the petitioner, Ext.P5 order of transfer, insofar as it relates to the petitioner, shall be kept in abeyance.
