Petitioner has approached this Court seeking police protection alleging obstruction by respondents 4 to 6 in the matter relating to conduct of business of M/s.Anoop Steel Furniture. According to him, he has his own registered workers who can do the work relating to the establishment.

2. Counter affidavit has been filed by respondents 4 to 6 stating that the area in question is a scheme covered area and the demand for work has been done only by the persons who are registered under Rule 26A of the Kerala State Welfare Loading and Unloading Workers Rules.

3. Though this case was posted on several occasions, there is no appearance on behalf of the petitioner. It is not disputed that the area in question is a scheme covered area.

4. The learned Government Pleader submits that despite filing the writ petition, no untoward incident had been reported in the area in question.

Having regard to the aforesaid factual situation, we do not think that any further orders are required to be passed in this writ petition and accordingly this writ petition is dismissed.
