JUDGMENT

This writ petition has been filed by the petitioners seeking various reliefs including a writ of mandamus directing respondents 3 and 4 to follow the seniority of temporary Anganwadi Workers/Helpers for regular appointment in Noolpuzha Panchayat, strictly in accordance with the Seniority Lists prepared as per Exts.P1 and P2 Government Orders.
