J U D G M E N T

SHAFFIQUE, J.

The petitioner has approached this Court alleging that there was threat from respondents 3 to 8. It is stated that during the pendency of the writ petition, respondents 3 to 8 had committed various offences against the petitioner and subsequently they were convicted and they are in prison.

2. The learned Senior Government Pleader submits that the police is keeping a constant vigil on the activities of respondents 3 to 8.

3. Having regard to the fact that the petitioner is under severe threat of respondents 3 to 8, there will be a direction to the police to have a constant vigil on the activities of respondents 3 to 8 and ensure maintenance of law and order situation.
