The election process is on. The final voters list was published on 10.6.2015. The list of candidates was published on 22.6.2015. Only the polling on 2.7.2015 remains.

2. It will be inequitable to interfere with the election process at this stage. Any complaint as regards the voters list can be raised in the election petition. The remedy lies only after the election is conducted. No direction to consider Ext.P5 complaint put in by the petitioner can be issued at this juncture.

The writ Petition is dismissed without prejudice to the right of the petitioner to file an election petition, if so desired.
