JUDGMENT

All that the petitioner seeks is for easy instalments to pay the amount due and to avert the sale of gold ornaments in the meanwhile.

2. I permit the petitioner to pay the amount in six equal monthly instalments starting from 15.07.2015. The coercive steps pursuant to Exts.P1 and P2 notices shall be put on hold if the petitioner complies with the conditions in time. The coercive steps shall surge ahead if the petitioner commits default in the payment of any one of the instalments as directed.
