JUDGMENT

Ashok Bhushan, Ag.C.J.

This writ petition has been filed alleging police harassment. Petitioners' case in the writ petition is that the first and second petitioners got married on 31.05.2015. The allegation is that the 1st respondent has called the 1st petitioner on telephone and directed to appear in person before him.

2. Learned Government Pleader submits that there being no complaint filed against the petitioners, no action is proposed to be taken at the instance of police authorities. He submits that no harassment is meted out to the petitioners at all.

Considering the aforesaid submission, we are of the view that no police harassment is meted out. Recording the submission of learned Government Pleader, the Writ Petition is closed.
