**J U D G M E N T**

The petitioner is aggrieved with the non-consideration of Ext.P5, an application for renewal of consent to operate a Unit engaged in the business of storage of raw hide and skins, which the petitioner is said to have applied for. The application was within time during the validity of the earlier consent on 20.06.2015.

2. In such circumstances, the application of the petitioner shall be considered after affording an opportunity of hearing to the petitioner, and a decision shall be taken within a period of two weeks from the date of receipt of a certified copy of this judgment, if necessary after conducting a physical inspection. If there is any objection raised, the objectors also shall be heard. If a decision is not taken within two weeks, then the petitioner can continue to

operate its Unit after the expiry of the said period, till orders are passed and the issue will then be governed by such orders.

The writ petition is disposed of.
