JUDGMENT

The petitioner approached this Court challenging Revenue Recovery proceedings.

2. The Revenue Recovery proceedings are initiated to recover the amount ordered by the Judicial First Class Magistrate, Sasthamcotta in C.M.P.No.334/2013 in M.C.No.20/2013. It appears that the above petition has been filed under Section 23(2) of Protection of Women from Domestic Violence Act, 2005. The petitioner seeks to pay the amount in 15 instalments.

I am of the view, it is for the Magistrate to consider such request. If the petitioner makes proper application before the Magistrate, necessarily, the Magistrate shall consider the application after issuing notice to the petitioner in that application. To work out the above relief, the coercive steps against the petitioner shall be deferred for a period of one month.

The writ petition is disposed of as above.
