JUDGMENT

The petitioners confine their relief to an early consideration of Exts. P2 to P31 applications on the basis of Ext. P1 judgment. The jurisdiction under Section 28A of the Land Acquisition Act, 1894 is purportedly invoked.

2. I direct the second respondent to consider Exts. P2 to P31 applications in accordance with law including the law of limitation. Needless to say that the petitioners and the fourth respondent shall be put on notice and heard in the exercise.

The writ petition is disposed of.
