JUDGMENT

The dispute relates to the pole rental for drawing television cables along the electric posts. Such disputes have to be resolved by the second respondent Chief Engineer as per the terms of Ext. P3 agreement. Ext. P7 representation put in by the petitioner in this regard is pending consideration.

2. I direct the second respondent to consider Ext. P7 representation with notice to the petitioner. The needful shall be done within a period of two months from the date of receipt of a copy of this judgment. The coercive steps as against the petitioner shall be put on hold if the petitioner deposits one half of the demand raised against him towards regularisation charges within one month.

The writ petition is disposed of.
