The petitioner is a registered dealer. Their stock transfer has been detained stating that there is no branch or godown at Puthussery, wherein the stock transfer is to be effected.

2. Admittedly, the petitioner's registration certificate does not contain the above Branch. The petitioner submits that they have applied for registration much before the detention and Ext.P4 is the application made through online. The petitioner also produced lease deeds as per Ext.P3.
