JUDGMENT

The electricity supply line has already been drawn across the property of the petitioners. The adequacy of compensation is pending consideration in a Civil Revision Petition. The petitioners now claim the benefit of Ext.P1 special compensation package. Ext.P2 representation addressed by the petitioners has now been made over to the third respondent. The third respondent is stationed at Bangalore whereas the petitioners are stationed at Kozhikode. It would suffice if the fourth respondent deals with Ext.P2 representation after notice to the petitioners. I direct the fourth respondent to consider Ext.P2 representation with notice to the petitioners.

2. The fourth respondent shall consider whether Ext.P1 special compensation package is applicable to the petitioners or not. The needful shall be done within a period of two months from the date of receipt of a copy of this judgment.

The Writ Petition is disposed of.
