J U D G M E N T

Petitioner has approached this Court challenging revenue recovery proceedings. The amount demanded in Ext.P3 is ₹1,68,350/-. However, it is admitted that now the balance is only around ₹41,000 + interest from 06.02.2015.

2. In that view of the matter, petitioner is permitted to discharge the entire liability in six monthly instalments starting from 05.08.2015. If the petitioner commits default in paying any of the instalments, the Bank is free to proceed against the petitioner.
