J U D G M E N T

Aggrieved by the non-consideration of Ext.P1 application for temporary permit, the petitioner has come up before this Court.

2. The petitioner, who is the owner of a stage carriage bearing Reg.No.KL-03/K 438, submitted Ext.P1 application for temporary permit to operate on the route between Ambalamkunnu and Kollam in the vacancy of a stage carriage bearing Reg.No.KL 2 T/7282. According to the petitioner, as the original bus is not operating, on account of non operation, there is temporary need for permit under Section 87(1) of the Motor Vehicles Act. Hence, the petitioner has approached this Court for a direction to the respondent to consider Ext.P1 application for temporary permit in the light of Ext.P2 judgment.
