JUDGMENT

Aggrieved by the denial of approval to the appointment of the petitioners as Office Attendants/Clerks, the petitioners have preferred Exts.P23 to P29 revision petitions before the 1st respondent. The limited prayer in the writ petition is for a direction to the 1st respondent to consider and pass orders on Exts.P23 to P29, expeditiously, after hearing the petitioners.
