The petitioner is aggrieved with the fact that the petitioner was not granted the second higher grade promotion in the post of Head Master. The very Government Order, which brought in the second higher grade was issued as G.O(P) No.515/85/Finance, dated 16.09.1985. The petitioner admittedly retired from service on the A.N. 31.09.1985 prior to the introduction of the Government Order. In such circumstance there would be no claim for a second higher grade promotion, same, the petitioner was out of service when the same was introduced.
