The issue involved in this writ petition is squarely covered in favour of the petitioners by Ext.P19 judgment of this Court. Accordingly, I quash Exts.P1 to P17 to the extent they impose a condition that the candidate in question is not entitled to vacation salary in the year 2012 in terms of Rule 49 of Chapter XIVA of the KER. The respondents shall take immediate steps to disburse the vacation salary that is due and payable to the petitioners in the writ petition within a period of three months from the date of receipt of copy of this judgment.
