JUDGMENT

Ext.P1 certificate shows that the petitioner is married to one M.K. Amesh. Exts. P2 and P10 series documents show that the couple is residing at Varappuzha in Paravur Taluk. Varappuzha is admittedly the area of operation of the first respondent bank. There is no reason as to why the grace marks under Rule 182(4) (IVA) of the Kerala Co-operative Societies Rules shall be denied to the petitioner. The issue is covered by Ext.P9 common judgment rendered in a bunch of writ petitions. It is the content and not the form of a certificate which is relevant to discern the home district.

2. Respondents 1 to 3 are directed to complete the process for appointment to the post of Junior Clerk in the first respondent bank. This shall be done after awarding the grace marks to the petitioner in terms of Rule 182(4) (IVA) of the Kerala Co-operative Societies Rules. It goes without saying that Ext.P6 rank list shall be recast after awarding grace marks to the

petitioner as indicated above. The needful shall be done within a period of one month from the date of receipt of a copy of this judgment.

The Writ Petition is disposed of. No costs.
