It has been reported from the Forensic Science Laboratory that it would be advantageous if any contemporaneous document containing the admitted signatures are produced. Over and above it, some more specimen signatures were also demanded. It seems that the petitioner has approached the investigating officer and has furnished all further specimen signatures as required.
