JUDGMENT

Shaffique, J

Petitioner has approached this Court seeking police protection alleging that there had been threat from respondents 5 to 11.

2. A statement has been filed by the fifth respondent narrating the facts that a series of complaints have been filed by the petitioner and there has been complaint against the petitioner also. It is stated that necessary enquiry has been made on the basis of the complaint given by the petitioner and this writ petition has been filed alleging false and frivolous complaints against private respondents. It is also pointed out that the petitioner has suffered several punishments including suspension, since 1991 and he had misbehaved to media persons in a drunken stage on duty.

3. Having regard to the nature of averments made in the statement filed, we do not think that the petitioner is entitled for any relief sought for. Hence we close the writ petition.
