JUDGMENT

The petitioner, challenging the detention order, has approached this Court. The reason for detention is that the goods unaccompanied by date of declaration. The petitioner is a registered dealer. The petitioner submits that there is an omission to produce 8F declaration.

2. The 8F declaration is a mandatory requirement for the goods under transport.

Considering the facts and circumstances, the goods shall be released to the petitioner on deposit of Rs.5,000/- and executing a simple bond for the remainder.

The writ petition is disposed of as above.
