**J U D G M E N T**

The petitioner, who is a Mazdoor working as cashier under the respondent Board, has approached the respondent Board with a representation seeking regularisation in service by relaxing the eligibility criteria. The limited prayer of the petitioner in the writ petition is for a direction to the 2<sup>nd</sup> respondent to consider and pass orders on Ext.P5 representation expeditiously, after hearing the petitioner.

2. I have heard the learned counsel for the petitioner and the learned Government Pleader for the respondents.
