The petitioner is aggrieved with the fact that Ext.P4 notification for walk-in-interview has been published to make provisional appointments to the post of Assistants.

2. It is submitted by all the Counsel appearing for the parties in the above writ petition that a Division Bench had considered the issue and had directed the University to make regular appointments within a period of six months and also directed that no fresh appointments shall be made and only the existing persons shall continue till such regular appointment is made.

3. In the teeth of such directions, the learned Standing Counsel appearing for the University submits that they

do not intend to proceed with Ext.P4. The said submission is recorded.

The writ petition is disposed of.
