JUDGMENT

The motion made by the petitioners under Section 28(A)1 of the Land Acquisition Act, 1894 was partly allowed. The petitioners being aggrieved have preferred Exts.P1 to P8 representations which are pending with the first respondent.

2. It requires to be seen whether Exts.P1 to P8 representations could be treated as one filed under Section 28(A) 3 of the Land Acquisition Act, 1894. The same shall be considered subject to the period of limitation after notice to the petitioners within a period of two months from today.

3. Needless to say that the petitioners shall be put on notice and heard in the exercise.

The Writ Petition is disposed of.
