JUDGMENT

It is conceded by all that the petitioner can operate the stage carriage as Limited Stop Ordinary Service only. This is in view of G.O.(P) No. 45/2015 dated 20.08.2015. The petitioner has already been granted the renewal of permit in the same lines by Ext.P2 proceedings. All that survives is the endorsement of the renewal to that effect in the permit.

2. The needful shall be done within a period of one week from the date of receipt of a copy of this judgment. The petitioner is permitted to operate the stage carriage as Limited Stop Ordinary Service till the endorsement is done.

The Writ Petition is disposed of.
