JUDGMENT

The petitioner, challenging Ext.P4 notice issued by the District Registrar(General). Kottayam, has approached this Court. The petitioner filed this writ petition on apprehending that based on Ext.P4, a document executed as Ext.P1 will be cancelled.

Learned Government Pleader submits that Ext.P4 is issued not as a part of the proceedings to cancel the document but as a part of an enquiry being initiated in relation to an illegality committed by the document writer. It is also submitted that party to the document as well as the Document Writer had committed fraud and fabricated document. It is based on that complaint, the enquiry is being initiated.

In view of the above, the petitioner shall co-operate with the enquiry initiated as per Ext.P4 and he shall respond to any notice issued by the District Registrar(General) as above.
