The order of status quo in W.A.Nos.227, 224 and 574 of 2001 does not disable the respondents from providing the electricity connection to the petitioners if the same is otherwise in order. So is the case with regard to the order of status quo in CMP.No.951/1995 in OP.No.551/1995 or the order in SLP.CC.Nos.5049, 5066 and 5067 of 2007.

2. Respondents 1 and 2 are directed to provide the electricity connection to the petitioners if the application put in for the same is otherwise in order. The needful shall be done within a period of two weeks from today.

The Writ Petition is disposed of.
