JUDGMENT

1. Petitioner is an applicant for allotment of industrial plot on hire purchase scheme. Petitioner was originally allotted a plot, but later it was cancelled at the instance of interference of third parties. Petitioner now submits that he is being denied the original seniority for allotment consequent to the cancellation. Petitioner highlighted his grievance before the 3rd respondent by filing Ext.P10 representation.

2. The 3rd respondent, if in receipt of Ext.P10 representation, shall consider the same and pass appropriate orders thereon, within a period of one month, after hearing the petitioner.
