JUDGMENT

Aggrieved by the denial of approval to the appointment of the petitioner as an HSST (Jr.) Ext.P6 revision petition has been filed by the manager of the school before the 1st respondent. The limited prayer in the writ petition is for a direction to the 1st respondent to consider and pass orders on Ext.P6 revision petition expeditiously.

2. I have heard the learned counsel appearing for the petitioner as also the learned Government Pleader appearing for the respondents.
