Petitioner has approached this Court seeking police protection alleging unlawful threat caused by respondents 4 to 8 and their associates in the matter relating to the functioning of her unit. It is alleged that respondents 4 to 8 have blocked the ingress and egress to the petitioner's unit. An interim order had already been passed on 25/08/2014 which has been clarified as per order dated 28/04/2015.

2. It is submitted by the learned counsel for the parties that presently there is no obstruction being caused by respondents 4 to 8 in the functioning of the unit and there is no strike. There is no law and order situation, as alleged.

3. Under such circumstances, we do not think that any further direction is required to be passed in this writ petition.

We close this writ petition with liberty to the petitioner to approach the police authorities, if any further cause of action arises.
