J U D G M E N T

The petitioner approached the passport authority to correct the entries in the passport. The request of the petitioner is to correct the following matters.

1. date of birth
2. spouse name
3. change in her name.

2. With regard to the correction of date of birth, it is to be noted that the difference is more than 2 years. In that view of the matter, correction can be only made based on the order of the civil court.

3. In relation to the correction of spouse name, the petitioner reserve her liberty to challenge the same at later stage.

4. In relation to correction of her name, this Court is of

the view that the request based on the certificate produced shall be considered by the passport authority in accordance with the law.
