J U D G M E N T

The petitioners contend that eligible persons are excluded and ineligible persons are included in the list for payment of compensation as per the Rehabilitation Scheme. The Rehabilitation is on account of the acquisition of the premises for the purpose of road widening.

2. Ext.P9 representation put in by the petitioners is pending consideration with the second respondent. I direct the second respondent to consider Ext.P9 representation with notice to all the persons mentioned therein (including the petitioners).

3. The above shall be done within a period of two months from today. The amount earmarked for payment of compensation shall be disbursed dependent on the outcome of Ext.P9 representation.

The writ Petition is disposed of.
