Heard the learned counsel for the petitioners, the learned Government Pleader and the learned counsel appearing for respondents 1 and 2.

2. By this writ petition, the petitioners are seeking for a writ of mandamus directing respondents 3 to 9 to afford adequate protection in connection with the election process as contemplated in Ext.P2. Ext.P2 is a notice for 110th Annual General Body Meeting and election of office bearers of the SNDP Yogam, Kollam.

3. Learned Government Pleader submits that when the earlier election was held on 4.9.2010, sufficient police personnels were present and no untoward incident had been reported. He submits that police are always ready to maintain law and order at the venue, if request comes from the appropriate authority.

4. In the above view of the matter, we see no reason to issue any direction to provide police protection. However, we only

observe that respondents 8 and 9 shall ensure that law and order is maintained at the venue of the election.
