JUDGMENT

Ext. P4 order relating to short assessment of electricity charges is challenged in Ext. P6 complaint before the fourth respondent forum. Ext. P6 complaint is accompanied by an application for stay of coercive steps. The petitioner apprehends disconnection of electricity supply even before the fourth respondent forum considers the interim relief.

2. I direct the fourth respondent forum to consider the application for stay filed along with Ext. P6 complaint. The same shall be done with notice to the petitioner within a period of one month. The coercive steps pursuant to Ext. P4 short assessment order shall not be enforced pending orders on the application for stay.

The writ petition is disposed of.
