JUDGMENT

Shaffique, J

Petitioner has approached this Court seeking police protection inter alia contending that petitioner is not being permitted to park and ply his autorikshaw at Angamaly town by respondents 5 to 7.

2. An interim order has been passed by this Court on 29.8.2014 directing maintenance of law and order. It is also observed that in any event there is any obstruction regarding parking of the vehicle at the approved place of parking, it is open for the petitioner to lodge a complaint before the concerned police officer.

3. Learned Government Pleader submits that thereafter no untoward incident has been reported.

4. Under such circumstances, we close this writ petition permitting the petitioner to approach the police if there is any further cause of action arises.
