The petitioner seeks consideration of Ext.P7 representation for constructing residential building in a paddy land. Ext.P7 is said to be filed before the Agricultural Officer, who is the convenor of the Local Level Monitoring Committee (LLMC). The application would have to be filed before the LLMC under Rule 5 of the Kerala Conservation of Paddy Land and Wet Land Rules, 2008.

2. In such circumstances, the petitioner has to make a proper application in Form No.1 under the Rules along with the documents upon which the LLMC would definitely have to consider the same.

The writ petition is disposed of leaving such remedy to the petitioner.
