Aggrieved by the denial of approval to the appointments of the petitioners as High Schools Assistants/Lower Grade Hindi Teachers in the 5th respondent School, the petitioners have preferred Exts.P3, P6, P8, P11, P14, P17, P20, P23, P26, P29, P32 and P35 revision petitions before the 1st respondent. The limited prayer of the petitioners in the writ petitions is for a direction to the 1st respondent to consider and pass orders on the revision petitions, expeditiously, after hearing the petitioners.
