JUDGMENT

The application put in by the petitioner for extension of provisional affiliation is pending consideration. The same is evident from Ext.P3 check status report of the said application. Ext.P5 affiliation bye-laws inter alia states as follows:

“Provisional Affiliation granted to a school will remain valid on receipt of application of a school for extension of provisional affiliation subject to the final decision of the Board”.

2. The last date for accepting application for travel concession of the students of the petitioner is 31.07.2015. The apprehension of the petitioner is that the respondent may not process the application for want of provisional affiliation. Ext.P6 application put in by the petitioner for availing concession for travel is pending consideration. I direct the second respondent to consider Ext.P6 representation with notice to the petitioner.

3. Ext.P6 representation for availing concession shall be considered in the light of the relevant clause in Ext. P5 affiliation bye-laws aforequoted. The needful shall be done within a period of one month from the date of receipt of a copy of this judgment.

The Writ Petition is disposed of.
