J U D G M E N T

Seeking a direction to the respondents to consider the petitioners' applications for regular permit in the next RTA meeting, the petitioners have come up before this Court.

2. The petitioners submitted applications for grant of regular permits on the routes, North Parur - Vyttila Hub and Kunjithai - Vyttila Hub. According to the petitioners, as the said routes falls within the jurisdiction of the respondents, no concurrence or countersignature is required from any authority. They allege that the proposed route passes through ill served area, where there is no sufficient service to cater the requirements of the travelling public. Exts.P1 & P2 applications are to be considered by the respondents. The petitioners' grievance is that the applications have not been considered so far.

3. It is submitted by the learned counsel for the petitioners that the RTA meeting scheduled to be held on 06.08.2014 stands adjourned to 17.08.2015.
