J U D G M E N T

Petitioner has approached this Court with a prayer to consider the application for One Time Settlement by the respondent Bank.

2. Learned counsel for the Bank submits that, there is no Scheme as such to consider petitioner's request. It is also submitted that the petitioner has already approached this Court in WP(C) No.14986/2010 and this Court granted instalment facility to clear the entire liability. The petitioner has not complied with the directions of this Court.

3. However, learned counsel for the petitioner submits that, the petitioner has complied with the directions, and that was in respect of another loan.
