JUDGMENT

The petitioner is aggrieved with the seizure of a Hyundai Accent Car bearing Registration No.KL-07-BG-4027.

The learned Government Pleader submits on instructions that, the car was driven by the 2nd accused in Crime No.259 of 2015 and when the police tried to apprehend him, the car was abandoned and the accused/driver ran away. It is in the said circumstances that the vehicle was seized. The vehicle is now said to be produced before the Judicial First Class Magistrate's Court-I, Kochi in pursuance to Crime No.259 of 2015 of Maradu Police Station.

In such circumstances, the petitioner would have to approach the learned Magistrate's Court for release of the vehicle.

Leaving open such remedy, the writ petition would stand closed.
