J U D G M E N T

The petitioners are aggrieved with the fact that the proceedings initiated under Section 20 of the Kerala Conservation of Paddy Land and Wet Land Act, 2008 (for brevity, Act of 2008) against the vehicles bearing Registration Nos. KL-49-A/6910 and KL-49-C/851 have not been finalised for the last three months.

2. In such circumstances, the petitioners shall appear before the 1st respondent on 10.08.2015 and the 1st respondent shall intimate a date of hearing on which date, the petitioner shall appear for hearing. The issue shall be considered and disposed of at any rate, within three weeks from the date of hearing. It is also made clear that if the petitioner wants to have

interim custody, the petitioner can move such an application, the application also shall be considered. The petitioner is directed to produce the certified copy of the judgment before the 1st respondent.
