JUDGMENT

Shaffiue, J

This writ petition has been filed seeking police protection in the matter relating to loading and unloading work being carried on by the petitioner in his premises. It is submitted that petitioner and his registered workers are having identity cards under Rule 26A of the Kerala Headload Workers Rules. An interim order has already been passed on 5.9.2014 directing the police to ensure maintenance of law and order and further to ensure that no obstruction is being caused by respondents 3 to 5. Learned Senior Government Pleader, on instructions, would submit that during the pendency of the writ petition, no untoward incident has been reported. Hence, we dispose of the writ petition in terms of interim order dated 5.9.2014.
