J U D G M E N T

The petitioner was aggrieved with the guidelines of selection of regular LPG distributors produced at Ext.P1. The learned counsel for the respondent would contend that the challenge made was to the guidelines which were applicable to all locations, advertised or re advertised from May 2013 onwards. Subsequently, there was a further guideline issued for advertisements from August 2013 and there had been many such revised guidelines which were issued on the operational experience of such allotments made. As of now, there is a guideline issued in March, 2015. The issue raised is with respect to no exclusive reservation of 3% being granted to the handicapped persons as per the The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995. The question would be left open. The writ petition shall stand closed with the above reservation.
