J U D G M E N T

The petitioner, who is the Manager of the School, has appointed the 3rd respondent as a teacher of the School. In the writ petition, the petitioner is aggrieved by the delay occasioned by the 2nd respondent in taking a decision with regard to approval of Ext.P1 appointment order, issued in favour of the 3rd respondent. It is therefore, that the writ petition has been filed seeking a direction to the 2nd respondent to take an expeditious decision in respect of approval of Ext.P1 appointment order.

2. I have heard the learned counsel appearing for the petitioner and the learned Government Pleader appearing for the respondents.
